List of County Petitions, c.1276–1377

This Appendix contains all known petitions presented in the name of single or multiple English counties between c.1276 and 1377. *PROME* references are to petitions enrolled on the parliament rolls: in the early fourteenth century, these were enrolled private petitions, but by the third quarter of the fourteenth century county petitions were frequently endorsed by the Commons and enrolled as common petitions—these are indicated by the abbreviation ‘CP’. Duplicate petitions are not included. Full editions of petitions in published work are indicated as follows:
