Tomas Balkelis is currently Senior Research Fellow in the Department of History, Vilnius University. He is also director of the international research project ‘Population Displacement in Twentieth Century Lithuania’ funded by the Lithuanian Research Council. Previously, he was a European Research Council Research Fellow at University College Dublin. His most recent books include an edited volume (with V. Davoliute) *Maps of Memory: Trauma, Identity and Exile in Deportation Memoirs from the Baltic States* (2012) and a monograph *The Making of Modern Lithuania* (2009). He has published articles in *Past and Present*, *Contemporary European History*, *Journal of Baltic Studies* and other journals.

Nick Baron is Associate Professor in History at the University of Nottingham, UK. From 2004 to 2009 he was co-director (with Professor Peter Gatrell, University of Manchester) of a UK Arts and Humanities Research Council-funded research project ‘Population Displacement, State Practice and Social Experience in the USSR and Eastern Europe, 1930-1950s’. He is the author of *Soviet Karelia: Politics, Planning and Terror in Stalin's Russia, 1920-1939* (2007, Russian edition 2011) and *The King of Karelia. Col P.J. Woods and the British Intervention in North Russia 1918–1919. A History and Memoir* (2007, Russian edition 2013), and co-editor (with Peter Gatrell) of *Homelands: War, Population and Statehood in Eastern Europe and Russia, 1918–1924* (2004) and *Warlands: Population Resettlement and State Reconstruction in the Soviet-East European Borderlands, 1945-1950* (2009). He has published numerous book chapters and articles on twentieth century Russian and East European history

and historical geography. He is currently writing a cultural study of Soviet cartography under Lenin and Stalin.

Rachel Faircloth Green received her PhD in History in 2006 from the Department of History, University of Chicago, USA. Her thesis was titled “‘There Will Not Be Orphans Among Us’: Soviet Orphanages, Foster Care, and Adoption, 1941-1956”.
